



Athlete Liability Release Waiver

I, _____ hereby acknowledge and agree to the terms and conditions set forth in this liability release waiver in consideration of being permitted to participate in the trampoline event organized by the Freestyle Trampoline Association (FTA) on _____, 2024 at _____ [LOCATION] in _____ [COUNTRY].

- Assumption of Risk & Release of Liability:** I understand and acknowledge that participating in trampoline activities involves certain inherent risks, including but not limited to the risk of bodily injury, falls, collisions, and other accidents. I voluntarily assume all risks associated with my participation in the event. I hereby release, waive, discharge, and covenant not to take any action against the FTA, its officers, directors, employees, agents, volunteers, successors, and assigns (hereinafter referred to as the "Released Parties") from any and all claims, liabilities, actions, demands, damages, costs, and expenses arising out of or in any way related to my participation in the trampoline event, including but not limited to personal injury, property damage, or death, whether caused by the negligence of the Released Parties or otherwise.
- Indemnification:** I agree to indemnify and hold harmless the Released Parties from any and all claims, liabilities, actions, demands, damages, costs, and expenses, including attorney's fees, arising out of or in any way related to my participation in the trampoline event.
- Medical Treatment:** In the event of any injury or medical emergency that may occur during my participation in the event, I authorize the Released Parties to obtain medical treatment for me as deemed necessary, including but not limited to first aid, emergency medical care, and transportation to a medical facility.
- Photography and Publicity:** I consent to the use of my name, likeness, voice, and image in photographs, videos, recordings, or other media captured during the event for promotional, advertising, or other purposes by the FTA [Event Organizer] or the event sponsors without compensation or further notice.
- Compliance with Rules:** I agree to comply with all rules, regulations, instructions, and guidelines provided by the FTA [Event Organizer] regarding the safe and proper use of the facilities and equipment. I also agree to follow the FTA's general 'Code of Conduct' at all times.

Athlete Code of Conduct

As a participant in an FTA event, I understand and agree to adhere to the following code of conduct:

1. **Respect:** I will treat all participants, officials, volunteers, and spectators with respect and dignity, regardless of race, ethnicity, gender, religion, sexual orientation, or ability.
2. **Fair Play:** I will conduct myself fairly, following the rules and regulations of the event and displaying good sportsmanship and fair play at all times.
3. **Safety:** I will prioritize the safety of myself and others, following all safety guidelines and instructions provided by event officials.
4. **Teamwork:** As I will be participating as a team, I will work collaboratively with my teammates, showing support and encouragement both on and off the event show venue.
5. **Responsibility:** I will take responsibility for my actions and conduct, both during competition and in any associated activities or events.
6. **Compliance:** I will comply with all event policies, procedures, and instructions provided by event organizers and officials.
7. **Respect for Facilities:** I will respect the facilities and equipment provided for the event, using them appropriately and reporting any damage or issues to event staff.
8. **Professionalism:** I will conduct myself in a professional manner, refraining from any behavior that could bring discredit to myself, my team, or the event.
9. **Substance Use:** I understand that being under the influence of drugs or alcohol prior to, or during the event, is prohibited.
